## PROMOTION/ACCELERATION/RETENTION

The Board of Education expects students to progress through each grade level within one school year. To accomplish this, instruction should accommodate the variety of ways that children learn and include strategies for addressing academic deficiencies when needed.

Students shall progress through the grade levels by demonstrating growth in learning and meeting grade-level standards of expected student achievement.

When high academic achievement is evident, the Superintendent or designee may recommend a student for acceleration into a higher grade level. The student's social and emotional growth shall be taken into consideration in making a determination to accelerate a student.

Teachers shall identify students who should be retained or who are at risk of being retained at their current grade level as early as possible in the school year and as early in their school careers as practicable. Such students shall be identified at the following grade levels: (Education Code 48070.5)

- 1. Between grades 2 and 3
- 2. Between grades 3 and 4
- 3. Between grades 4 and 5
- 4. Between grades 6 and 7
- 5. Between grades 8 and 9

As early as possible in the school year, the Superintendent or designee shall identify students who should be retained and who are at risk of being retained in accordance with law, Board policy, administrative regulation and the following criteria:

- Grades 1-2: Reading grades and the district assessment of reading and writing proficiency.
- Grades 3-6: Reading, Language arts, and math grades; and the district assessment of reading, language arts, and math proficiencies.
- Grade 8: Math and English grades; the district assessment of writing and math; the student's cumulative grade point average.

# PROMOTION/ACCELERATION/RETENTION (continued)

In addition, at each of the grade levels, other critical considerations will be taken into account, e.g. English Learner status, IDEA plans or modifications, previous retention and extenuating circumstances (e.g. family death, health, divorce, etc.)

If a student does not have a single regular classroom teacher, the Superintendent or designee shall specify the teacher(s) responsible for the decision to promote or retain the student. (Education Code 48070.5)

The teacher's decision to promote or retain a student may be appealed in accordance with AR 5123 – Promotion/Acceleration/Retention.

When a student is recommended for retention or is identified as being at risk for retention, the Superintendent or designee shall provide opportunities for remedial instruction to assist the student in overcoming his/her academic deficiencies. Such opportunities may include but are not limited to tutorial programs, after-school programs, summer school programs and/or evaluation by a student study team in accordance with Education Code 37252.2.
